### Summary of Essential Elements of Citing/Referee/s Report/Footage

The Referee's report stated:

"Dry winters day, 3pm kick off so played for duration under floodlights. Light significantly dropped from half 1 to half 2. Fantastic first half of rugby played in perfect rugby spirit. 1 minute into second half Henley 2nd rows clashed heads and had to be removed for concussion. Messy next 15 minutes whilst Henley tried to sort themselves out. Hooker for Henley under pressure at line out and scrum due to losing both 2nd rows in earlier incident which lead to frustrations.

Penalty awarded to Bury st. Edmunds around their own 22m in the ruck. Players in the area stood up and grabbed one another in a small fracas. This was the first of the game. Majority of players broke up except for the Henley hooker and a Bury st. Edmunds player. The Henley Hooker then used the phrase during an exchange of words "Fuck off you Faggot". At this point the players continued to grapple. This was over momentarily afterwards and the Bury St. Edmunds player then turned to me and repeated what the Henley player had said. I called the captain of Henley over to myself with the hooker and issued a red card for use of a homophobic slur.

After the game the Henley Hooker came to the changing rooms and apologised to myself, two AR's, 4th official and Assistant Referee coach who were also in the room. He stated his apology again in the bar area after the game and stated it was completely out of character."

### Summary of Player's Evidence

In relation to the Player, he stated in his statement:

"The situation stemmed from a breakdown scenario. An intense, physical encounter played on the edge by both teams. We were in possession of the ball, in a threatening and attacking position on the field.

One of my team mates had carried the ball in to contact, and as the nearest support player, I aggressively and legally removed the breakdown threat. The Bury St Edmunds player then pursued to hold me down post contact, not allowing me back to my feet and back into the game. As I tried to get back up, the opposition player pushed my head into the floor, resulting in a reaction from myself. This resulted in some pushing and shoving from myself and the opposition player as I got back to my feet and a penalty was awarded.

In the heat of the moment and in confrontation, I used terminology in which I wholly regret. This was uncharacteristic of myself, meaningless and said with absolutely no intent. The player didn't take any offence, we were removed from the situation, and both got back into position as the penalty was awarded. On reflection, this was wholly unacceptable and which I deeply regret. There is no excuse for homophobic language. However, I can only assure everyone involved both in and outside of the game that I take responsibility for and apologise for the language and terminology used at this one point in the game, and my career.

At the conclusion of the match I visited the Match Officials and apologised to the Referee and his colleagues.

I then with our Captain Sam Lunnon, visited the Bury St Edmunds changing room to apologise to the player concerned. This was wholly accepted by the player concerned. Once changed I then found the Henley RFC Chairman – Chris Nixon and apologised for the comments I made on the field of play. I explained that this should not have occurred and that I am very sorry."

In live evidence he explained that he was cleaning the opposition player out when the penalty was awarded, although at the time he was not sure for what. All the players started getting to their feet, from the ruck, and the opponent grabbed him and pulled him down. It was at that stage that they tussled and the Player uttered the abusive language. He explained that it had been a 'heat of the moment' reaction.

The Player explained that he had had an emotional week with family losses which may have contributed to his demeanour but stated that nevertheless his actions were unacceptable. Once the Referee had shown him the red card he apologised to his opponent and the match officials after the game.

Mr Dudding stated: "I have known Tom for some four years since joining Henley Rugby Club. He is an outstanding rugby player who I know holds the core beliefs and values of rugby in high regard. The incident on Saturday 7th December was totally out of character and his subsequent apologies to all concerned speak volumes for him. The remark was clearly an ill judged and inappropriate one which Tom accepts without question. It was however said in the heat of the moment whilst being held down on the ground and then pulled from a ruck situation."
