#### Summary of Essential Elements of Citing/Referee/s Report/Footage

The referee's report stated:

"As Cornish Pirates were attacking just inside the Doncaster 22m line I received a call from assistant referee Simon Park (SP) that there had been foul play by Doncaster and that I should stop the game.

SP described a forceful push by Doncaster 11 into the face of Cornish Pirates 3. After confirming that the push was with force & when asked for a recommendation SP advised a red card sanction.

This is an act of foul play contrary to law 9.12 - A player must not physically or verbally abuse anyone. Physical abuse includes, but is not limited to, biting, punching, contact with the eye or eye area, striking with any part of the arm, shoulder, head or knee(s), stamping, trampling, tripping or kicking.

Doncaster 11 was sanctioned with a red card and on the way off the field apologised to Cornish Pirates 3."

The assistant referee's report stated:

"Following a lineout to maul sequence that started on the Doncaster 22, play moved infield to a ruck just outside of the 15m line. Play continued with CP3 on top of DK11 after the breakdown.

The players were holding each other but it was unclear from my position what exactly was happening. CP3 then stood up and tried to re-join play. DK 11 grabbed CP3's shirt who turned round and then DK11 forcefully pushed CP3 in the face with both of his hands.

CP3 staggered backwards and then went to his knees before dropping onto his back. At this point I informed the referee to stop the game, which had continued to move away from me to the other side of the pitch, as I had seen foul play. The referee could have no view of the incident. At this stage CP3 was receiving medical attention from 2 of the CP medical staff.

The game was stopped, and I reported to the referee I had seen a forceful push with 2 hands to the face of CP3 by DK11. When asked for a sanction I believe there had been sufficient force in the push to warrant a red card.

The referee called over the DK 11 and his captain, verbalised my report to them both and issued DK11 a red card."

The video footage accords with the AR's report of the incident. However it also clearly records the actions of the victim player (CP3) prior to the incident. He approaches the ruck and clears the Player out rolling him onto his back. He gets up onto both feet and is holding or is being held by the Player as he gets up. He then forcefully drops his right knee onto the chest/groin area of the Player. He then stands up with the Player continuing to hold CP3's right arm and turns to move away. The Player stands up at which point CB3 turns to face him and the Player then pushes CB3 away. CB3 goes down on one knee and then "collapses" onto his back whilst holding his head.

| An undated statement was received from Doncaster RFC stating:  |
| "Maliq would like to submit a guilty plea in relation to the above charge.   |
| Maliq immediately apologised and checked on the wellbeing of CP3 before leaving the field and again post-match. Maliq also repeatedly showed remorse whilst in the dugout for the remainder of the game.   |
| Maliq admits to reacting out of frustration after taking a knee to the chest from CP3 whilst he was prone on the ground. There was no intent to make contact with the face or head of CP3, the gesture was intended to simply push the player in the chest to distance him from Maliq. |
| Maliq has a previous clean record and is of outstanding character. He hopes this will stand in his favour."  |

### Reasons for selecting entry point:

Although there was "an act of Foul Play which result(ed) in contact with the head", the mandatory minimum mid-range was not applied. The SJO, having considered all of the factors in the circumstances of this particular case and footnote 1 ii of Appendix 2 of Regulation19, decided that the sanction if the mandatory minimum mid-range was applied would be "wholly disproportionate" to the Player's "fault and the consequences thereof".
