#### Summary of Essential Elements of Citing/Referee/s Report/Footage

The Citing Commissioner's (Andy Blyth) report read:

"Leicester (L) drive a maul from a lineout. L2, Tom Youngs, is in possession Wasps (VV) are penalised for collapsing the maul. As a result of the collapse W4, Will Rowlands, finds himself lying prone over the top of L2. Without any obvious provocation L2 punches W4 with a clenched Fist making contact on the cheek/eye area. As a result W4 has a cut at top of cheek bone under right eye. W4 receives treatment on field then plays on.

The incident was not seen by the referee and therefore no action was taken on-field. However conversation can be heard over the referee microphone with Wasps players suggesting to referee that a punch had been thrown. The TMO check did not immediately find the incident and play continued, to then later be found but too late to take any action.

Post match I spoke with W4 who confirmed that he had been punched by L2 and the injury under his eye was as a result.

Having studied all television angles and considered all evidence available I believe that this incident of foul play passes the Red Card test and I hereby fully cite Tom Youngs L2 under Law 9.12 for Striking."

The footage was viewed, which was broadly consistent with the narrative as set out above provided by the Citing Commissioner.





Statement from Mr Rowlands (W4) recorded:

"After the maul collapsed, I was lying on top of Tom who then swung his fist into my face. it was unprovoked, but he did immediately apologise and then subsequently apologised at the end of the game".

Medical evidence from Wasps reported:

"Will Rowlands was attended to on the field of play for abrasion under the Right eye. The player reported that he sustained the injury from a punch to the eye by an opposing playing named as Tom Youngs.

There was no associated bony injury to the eye or nose and there was no evidence of Concussion on examination during or after the game.

Abrasion did not require an suturing during or after the game. It will be monitored and is expected to heal without further intervention."

It was further confirmed that Mr Rowlands was fit to play and had joined up with the Wales squad ahaed of the upcoming 6 Nations weekend.



#### Summary of Player's Evidence

Additional footage was submitted at the hearing on behalf of the Player. The source of the footage was unclear, but the Panel understood from Leicester that it had been obtained from a Twitter feed on the day of the hearing. It was submitted that this showed W4's left hand on the Player's genitals. Whist it was not asserted that this had been intentional, it had led to the Player striking out in reaction to that contact.

The Player gave evidence and confirmed he accepted that he had committed an act of foul play that had warranted the issue of a Red Card.

He further realised that he had let his club down and the game more widely. He was a player who played to the limits, but was not a dirty player. His reaction was instantaneous but out of character and one that he had very much regretted. He had immediately apologised to W4 after the incident and had done so again after the game. He had not mentioned the contact with his genitals prior to the additional footage becoming available.

Mr Cohen noted that the offending would have to be assessed at being at the mid-range of the scale of seriousness. However, and notwithstanding that the Player had two previous offences recorded against him, in is submission in all the circumstances the Player should still receive the maximum permitted 50% reduction from the entry point.

He advanced two points in support of that submission:

1. As regards the previous offences, the first had been in (January) 2016 and should therefore be disregarded. The second in 2019, had been found to have involved reckless rather that intentional offending. Accordingly, this was the first offence that had involved deliberate foul play, throughout the Player's lengthy career; and

2. The Player had reacted to contact, albeit that this had been unintended, with his genitals.



#### Findings of Fact

The Player, on his own admission, had committed an at of foul play.

The offending involved a single strike to the head of W4, with a closed fist. As such, again on the Player's own admission, the Referee had been correct to issue a Red Card.

Minor injury had been sustained to the right side of W4's face below the eye.

#### Summary of reason for number of weeks deducted:

The arguments advanced on behalf of the Player in support of his being granted a 50% discount from the enrty point were rejected.

The Player has two other matters recorded against him in the past 4 years, and in those circumstances the Panel held that he was not entitled to full mitigation.

In light of his early plea, remorse and conduct at the hearing, the Player was entitled to a 30% reduction form the entry point, amounting to 2 weeks.
