# Summary of Essential Elements of Citing/Referee/s Report/Footage

The referee's report indicated that the incident occurred in the 2nd half, when the score was 12-7. It was an evening game under lights, played on a very hard pitch under a good grass pitch.

The report stated:

"A lineout occurred just inside the Hartpury 22 with jersey throwing in. At the lineout I played a penalty advantage to jersey for contact in the air. The ball was recycled twice before the event with a second advantage being played to Jersey for an offside against Hartpury. As the Jersey player carried the ball into contact he was tackled by Hartpury 10. To assist his own player in contact Jersey 4 then comes into the tackle. He then lifts Hartpury 10 around the middle and legs. As he lifts the Hartpury 10, the Hartpury 10 goes beyond the horizontal and falls towards the ground. Jersey 4 continues to drive the player towards the ground with the Hartpury 10 initially putting out his arms to protect himself but still lands with head first into the ground.

I immediately blew the whistle and cleared the two teams where players had attempted to come in to react to the incident. To give time for the players to calm down I went over to the AR to explain what I had seen and my decision. As a team of officials we agreed the actions met the sanction of a red card and this was issued to the player. The player left the field immediately."

The video footage reflected the referee's description. Of note was:

### Essential Elements of Other Evidence (e.g. medical reports)

Richard Mack Lead Physiotherapist Hartpury University RFC, stated: "In the second half of the game against Jersey RFC on Friday 6th May I attended to James Williams, the Hartpury RFC fly-half. James did not return to his feet after being tackled and I approached to assess. He denied any neck pain or neurological symptoms and he was alert. After clearing any significant neck injury he reported feeling •windedŽ.He was able to roll onto his side and move into a seated position. He had no central spinal pain but did complain of some para-spinal stiffness. He describes being forced into extension through his mid-back. On returning to his feet he felt ready to play and following the game did not present with any issues." The referee's report indicated that Mr Williams continued to play. There was no further medical evidence.



### Summary of Player's Evidence

The Player gave evidence before us which complemented his helpful written statement:

I, Sean O•Connor, was playing in the Championship Cup second leg quarter final between Jersey and Hartpury. I started at lock (number 4).

During the game, my teammate Wes White ran a set play in which I was due to support him and seek to latch onto to him as he moved into contact.

We are coached to clear out towards the opposition try line and to stay as square to the try line as possible.

As I approached the contact area, Hartpury's number 10 has attempted to tackle and hold up our player.

As this happens, the Hartpury players back ends up facing me.

I proceed to join the tackle and attempt to remove the opposition player.

As I drive the player in the direction of his own try line, my teammate regains his feet underneath us and continues his ball carry. In doing so he turned to the left and went underneath the Hartpury player. This causes the Hartpury•s players legs to go above the horizontal and forces me to drive him down, rather than in the direction of his own goal line. Hence, leading to the incident in question.

Immediately after the game, I found the player, expressed my remorse, and apologised. There was absolutely no malice in the incident, which I felt was an accident caused by Wes driving in an unpredictable direction which took him underneath the Hartpury player.

I take my contact skills very seriously and spend considerable time developing and practising them. I have committed to reviewing my techniques and conduct in the contact area with Harvey Biljon and other coaches in the light of this incident.

The Player's evidence to us reflected this. He was clearly genuinely remorseful as to what had happened. In answer to the Panel as to why he had put left arm between legs, the Player candidly and honestly stated that this was not ideal. He said that this was the 46th minute his lungs were probably burning after a rest and he was probably not thinking clearly enough to notice where his left arm was going. He further acknowledged that with hindsight, he would probably like to have been a bit lower instead of using his hands. He perhaps would have used his shoulder a bit more and maybe gone in lower.

Wesley White gave evidence in line with his written statement.

Both players were assisted by talking us through the videos.



### Findings of Fact

The Panel made the following findings on the balance of probabilities:

- 1. J22 carried the ball into contact. Initially he was tackled by H10, who was then supported in the tackle by H8. All three players remained on their feet, with H10 attempting to hold/rip the ball from J22.
- 2. The Player, in supporting his teammate, J22, bound onto H10. H10 had shifted his body position as the Player bound onto him; he was sideways on to the Player.
- 3. The Player was in too high a position and was not in a position to be able to drive H10 clear of J22 using his shoulder.
- 4. Initially, the Player•s right arm was over H10•s shoulder/chest area and his left arm was on H10•s back.
- 5. J22 continued to drive forward.
- 6. The Player then shifted his bind and placed his left arm between the legs of H10. His right arm continued to be placed over H10•s shoulder/chest area.
- 7. As J22 moved forwards, the Player, whilst attempting to clear H10 out, lifted H10•s legs off the ground using his left arm.
- 8. H10•s legs were lifted above the horizontal line and he was dropped/driven into the ground. H10 landed on his head in very dangerous position.
- 9. We wholly agreed with the submissions of Mr Barnes for the RFU that this was a reckless act. It was not deliberate. There was no element of malice at all.
- 10. We had some sympathy for the Player and accepted the submission from Mr Thomas that this was a complex dynamic situation.
- 11. However, all the elements of the offence were made out.
- 12. This clearly merited a Red Card.
- 13. Having reminded ourselves of the burden and standard of proof, we found the case proved.
