

**NATIONAL SCHOOLS CUP COMPETITIONS REGULATIONS
2020-21**

PART A: COMPETITION REGULATIONS SCHEDULE

A. Competition(s)	<p>1. For the purpose of these regulations, ‘Competition’ shall mean:</p> <ul style="list-style-type: none"> <input type="checkbox"/> Under 18 Cup <input type="checkbox"/> Under 18 Plate <input type="checkbox"/> Under 18 Vase <input type="checkbox"/> Under 18 Bowl (together ‘the Under 18 Competitions’) <input type="checkbox"/> Under 15 Cup <input type="checkbox"/> Under 15 Plate <input type="checkbox"/> Under 15 Vase <input type="checkbox"/> Under 15 Bowl (together ‘the Under 15 Competitions’)
B. Competition Organiser	<p>1. The Competition will be organised by the RFU Competitions (Development) Department on behalf of the RFU and ERFSU.</p>
C. Disputes Committee	<p>1. For the purpose of these regulations ‘Disputes Committee’ shall mean: Disputes Committee (Community Competitions).</p>
D. Competition Format	<p>1. The Competition Organiser will place participating teams into the U18 Cup, U18 Vase, U15 Cup or U15 Vase as appropriate.</p> <p>2. There will be 128 places in the U18 Cup and 256 places in each of the U18 Vase, U15 Cup & U15 Vase competitions.</p> <p>3. The Competition Organiser will carry out the draws. When conducting the draws, every reasonable endeavour will be made to minimise travel.</p> <p>4. The first-named team in the draw is the home team and the second-named team is the away team, irrespective of where the game is actually played.</p> <p>5. The Competition will be based on a straight knockout format.</p> <p>6. The structure of the Competition is set out in Annex 1.</p> <p>7. Entrants that fail to reach the second round of the U18 or U15 Cup will automatically be entered into the U18 or U15 Plate respectively.</p> <p>8. Entrants that fail to reach the second round of the U18 or U15 Vase will automatically be entered into the U18 or U15 Bowl respectively.</p> <p>9. The Competition Organiser will determine the date, kick off time and venue of the semi-finals and finals of the Competition.</p>

<p>E. Entrant Eligibility</p>	<ol style="list-style-type: none"> 1. The Competition will be open to educational establishments in membership of the ERFSU, subject to the remaining provisions of these Regulations and the discretion of the Competition Organiser. 2. An educational establishment will only be eligible for the Competition upon it providing evidence that at least one member of staff has completed the relevant HEADCASE online concussion module at the time of application. 3. Any Entrant participating in the RFU AASE Competition will not be eligible to participate in the Competition. 4. Any Entrant conceding a match will be removed from all Competitions for that season in respect of that age grade. 5. Any Entrant which withdraws from any Competition in two successive years may be ineligible to enter that age group's competition in the following year. The decision on such eligibility will be made by the Competition Organiser after consultation on the reasons for withdrawal. The decision will be made before the end of the second Season in which the withdrawal is made, and shall be subject to appeal pursuant to Regulation 11.
<p>F. Player Eligibility</p>	<ol style="list-style-type: none"> 1. Players must be under 15 years of age at midnight on 31st August of the effective season to be eligible for the U15 Competitions. Players must be under 18 years of age at midnight on 31st August of the effective season to be eligible for the U18 Competitions. 2. Players taking part in a Competition must be on the roll of the participating educational establishment on 30th September of the effective season and still in attendance at the participating educational establishment, unless otherwise agreed by the Competition Organiser. 3. All teams must comply with RFU Regulation 15, including eligibility requirements for playing up, and the restrictions on playing in the front row. U16s and U17s can only play in an U18 match if the conditions of RFU Regulation 15 are satisfied. U16s cannot in any circumstances play in the front row of the scrum in any U18 match (unless the player is an England Academy Player and satisfies the requirements of RFU Regulation 15). 4. In the U18 Competitions only a total of three players who have joined the educational establishment in years 11, 12 and 13 are permitted to be part of the squad of players selected, subject to compliance with RFU Regulation 15 in all circumstances. 5. However, Regulation F.4. shall not apply to educational establishments that have been granted Collegiate School Status for the effective season (the requirements for which are set out below). Educational establishments who have been granted Collegiate Status will only be permitted to have in their matchday squad a total of 3 players who joined

	<p>in years 11, 12 and 13, if they are not from an approved feeder school.</p> <p>6. Collegiate School status can be granted by the Competition Organiser to educational establishments participating in any of the U18s Schools Cup Competitions in the following circumstances:</p> <ul style="list-style-type: none"> i. If a state educational establishment provides education up to and including the age of 18 years of age and some of its pupils feed into its Sixth Form as part of a normal transfer at this age from a local School/College, or local Schools/Colleges, which only educate pupils up to the age of 16 years, it may apply to the Competition Organiser for registration as a Collegiate School. ii. Collegiate Schools may select any number of such pupils, along with those which have come through the school anyway, to play in the U18 Competitions, provided that the Competition Organiser has approved their application for registration as a Collegiate School in accordance with this Regulation. iii. Only State educational establishments can apply for Collegiate School status. Any State educational establishment that wishes to register as a Collegiate School must complete and submit the relevant form. Applications must be submitted by a date determined and notified by the Competition Organiser. The Competition Organiser reserves the right to decline any application for Collegiate School status. iv. Where pupils in two or more educational establishments in the same area are taking one or more subjects in one educational establishment and one or more subjects in a second educational establishment, then players from both the educational establishments involved can play in the team of one or other of the institutions involved, provided that institution has been granted Collegiate School status in accordance with this Regulation and subject to the approval of the Competition Organiser. <p><i>Note: In recognition of the fundamental purposes of this Regulation (ensuring safety, fairness and equity for all participants), any team breaching any part of Regulation F.4 & F.5. risks disqualification from the competition.</i></p>

<p>G. Match Management</p>	<p>Team Sheets</p> <ul style="list-style-type: none"> 1. The School attended in Year 11 for each player must be included on the Team Sheet (U18 competitions only) 2. Each entrant in every match of the Competition must complete and retain a copy of a Team Sheet of the starting players and replacements. Entrants must also submit a copy to the Competition Organiser, within 48 hours of the final whistle of each match, signed by the Team Manager.

	<p>Squad</p> <p>2. A squad of up to 22 players (15 starting players and 7 substitutes/replacements) can be named for each match. Squad composition must be in accordance with the Laws of the Game.</p> <p>Match</p> <p>3. U15 matches will be 30 minutes each way. Half-time will be 5 minutes, with both teams staying on the Field of Play.</p> <p>4. U18 matches will be 35 minutes each way. Half-time will be 5 minutes, with both teams staying on the Field of Play.</p> <p>5. Should a fifty-point differential occur at any time during a match, the Referee may end the match and the result at that time will stand, unless both teams are in agreement to continue.</p> <p>Fixtures</p> <p>6. Where the Home team is unable to provide a suitable venue for the match, the fixture must be reversed and played at the Away team venue to ensure the match is completed by the due date. If neither venue is available, the matter must be referred to the Competition Organiser, which has the power to extend the date by which the match must be played or to decide which team shall go forward to the next round. Failure to provide a suitable venue will also include being unable to provide a suitable venue in the event of bad weather.</p> <p>7. Where a fixture is reversed in accordance with Regulation G.6. the Home team will remain as published in the draw.</p> <p>8. Where the first-named Entrant to be drawn in a match plays its home fixtures in the Isle of Man or the Channel Islands, the match shall, unless both Entrant agree to play off-shore at the expense of the off-shore Entrant, be played on the mainland of England on the ground of the second-named Entrant to be drawn.</p> <p>9. Where a match has not been played, or the result of a match remains unresolved, by the end of the stipulated week, the Competition Organiser may, in its sole discretion, determine which team (if any) will progress in the competition(s). This power will only apply to situations where there is no other opportunity to play/replay a match and the successful delivery of the competition(s) is at risk.</p> <p>Match Officials</p> <p>10. The home team will provide a Referee Society appointed Referee.</p> <p>11. The home team must advise the Referee that the appointment is to a Competition fixture and advise him/her of the Competition Regulations and appropriate Law Variations.</p>
	<p>12. If a Referees' Society is unable to appoint a Referee, the home team may ask a neutral educational establishment to provide an experienced member of staff to act as Referee or to recommend a neutral, experienced referee from outside the educational establishment. This is only</p>

	<p>permissible if the away team is notified in advance, and both educational establishments playing in the competition are in full agreement with this arrangement prior to the game being played.</p> <p>13. If a Society or neutral referee is not available, the away team must be offered the opportunity to provide a referee, or they can consent to a proposed home referee.</p> <p>14. H. Notification of Results	<p>1. The winning entrant must inform the Competition Organiser of the result within 2 hours of the end of the match.</p> <p>2. I. Other Competition Specific Regulations	<p>Accommodation & Travel Expenses</p> <p>1. A contribution towards transport and accommodation costs for the Semi-Finals and Finals will be made through the Competition Organiser, if applicable.</p> <p>2. For funding purposes, the travelling party will consist of 26 per team – 22 players, 3 members of staff and 1 coach driver.</p>

PART B: COMPETITION REGULATIONS

1. Introduction

- 1.1. These Competition Regulations, together with the above Schedule and any attached Annexes (together the “Competition Regulations”), set out in full the regulations that shall apply to this Competition.
- 1.2. These Regulations apply to the Competition in the 2020-21 season and are effective from 1st August 2020.
- 1.3. All matches must be played in accordance with these Regulations, World Rugby Laws and Regulations (including any variations and trials that may be adopted by the RFU), World Rugby Regulations and RFU Rules and Regulations. In the event of any conflict between a provision of these Regulations and the RFU or World Rugby Rules and Regulations, these Regulations will prevail in respect of that provision.
- 1.4. Unless otherwise specifically defined in these Regulations, any definitions will have the meanings set out in the RFU Regulation 1 (Definitions) which is available on the RFU website.

2. Competition Organisation

- 2.1. The Competition will be administered by the Competition Organiser who shall manage the delivery of the Competition.
- 2.2. The Competition Organiser shall have discretion to decide on matters not provided for in, as well as on the interpretation of, these Regulations in the context of the Competition. This discretion shall include the interpretation of these Regulations in accordance with the underlying principles and intent (insofar as it can be ascertained) of the relevant regulation and in the interests of rugby union football.
- 2.3. Any interested party may seek clarification of any of these Regulations by submitting a question to the Competition Organiser in writing.
- 2.4. Any party affected by a decision of the Competition Organiser on matters not provided for in the Competition Regulations shall have a right of appeal against such decision in accordance with Regulation 11 below.
- 2.5. In the discharge of its responsibilities, the Competition Organiser may further delegate some or all of the powers contained within these Regulations to any individual member(s) or staff member(s) of the Competition Organiser.

3. Match Management

Team Sheets

- 3.2. The Team Sheet will contain the following information:
 - a) Full Name of Player
 - b) Date of Birth of Player

- c) Front Row (tick if applicable)
- d) Such other information as required in the Regulations Schedule

- 3.3. Each Team Manager must sign the team sheet (where indicated) prior to the start of the match.
- 3.4. Each entrant must ensure that information provided on the Team Sheet is accurate and legible. Failure to submit a team sheet, or late submission, will render an entrant liable to sanction. The provision of false or misleading information on players or replacements is a serious breach of these Regulations and may give rise to a severe penalty.

Half Game Rule

- 3.5. The Half Game Rule will apply to all matches in the Competition in accordance with RFU Regulation 15.12. Suspected breaches of this regulation will be referred to the Disputes Committee in accordance with the process outlined in Regulation 9.2.

Fixtures

- 3.6. The home team is responsible for arranging the fixture at a suitable venue (defined as the usual home pitch, or alternative school/club/artificial pitch) for all matches with the exception of those listed in the Regulations Schedule.
- 3.7. Matches must be played by the end of the stipulated week as detailed by the Competition Organiser. Should this not be possible, the home team must contact the Competition Organiser to apply for dispensation to play on an alternative date.
- 3.8. The Competition Organiser retains the right to specify the date and kick-off time for any match in the Competition.
- 3.9. In all matches in the Competition, Entrants must select their strongest squad of eligible players.

Kit

- 3.10. Each team is responsible for ensuring that there is no clash of colours and that all its kit complies with World Rugby Regulations.
- 3.11. The home team will change shirts in the event of a clash of colour.
- 3.12. All teams must wear numbered shirts in the Quarter Finals, Semi Finals and Final of the Competition as applicable.

4. Replacements

- 4.1. Rolling Substitutions are permitted in all matches. A player who has been substituted may later replace any player, whether or not that player has been injured (subject to Regulation 4.2).
- 4.2. Subject to 4.4 below, if on any occasion a front-row player requires to be replaced and his team cannot (for any reason, including injury, temporary blood injury, temporary exclusion following a yellow card, or permanent exclusion following a red card) provide a replacement, or another suitably trained and experienced player from the nominated squad, to enable the match to continue safely with contested scrums, the Referee, having made enquiry of and having confirmed this fact with the manager of the team (or such other person nominated by the Entrant as the person responsible for the team), the match will continue with uncontested scrums. The team concerned shall not be entitled to replace the player whose departure caused the uncontested scrums and (subject to Regulation 4.4 below) the final result will stand. On return to the field of play of the front-row player who had been temporarily excluded or injured, the Match shall continue with contested scrums.

- 4.3 In the unusual event that a Referee decides to continue the game with uncontested scrums on the grounds of safety, because the official cannot safely manage the scrums otherwise, the final result will stand, subject to Regulation 4.4.
- 4.4 The Competition Organiser may review the circumstances where a match is completed with or contains uncontested scrums and in its sole discretion may impose penalties in accordance with Regulation 10, subject to the right of appeal set out in Regulation 11.

5. Drawn Matches

5.1. Matches in a League Format (if applicable)

In the event that the scores are level at the end of the match, the match will be considered a draw. There will be no extra time.

5.1. Matches in a Knock-Out Format (other than the final)

In the event that the scores are level at the end of a match, the winner of the match will be the team that has scored most tries. If this does not produce a winner, the team that has scored the most conversions from tries will proceed to the next round. If this still does not produce a winner or the score is 0-0, the away team shall proceed to the next round.

5.2. Final

If scores are level at the end of the match, the following order of events shall be applied in order to determine the winner of a drawn match: number of tries, number of conversions from tries, first try, first points. If this does not produce a winner or the score is 0-0, the title will be shared.

6. Postponed or Abandoned Matches

6.1. Weather Conditions (including bad light)

6.1.1. Postponed Match

If weather conditions (including bad light) prevent a match being played, despite the teams having followed any Postponed Match Notification Procedure as may be notified to the participating Entrant by the Competition Organiser, the match will be played at a later date unless the Competition Organiser exceptionally, and in its absolute discretion, agrees/specifies otherwise.

6.1.2. Abandoned with Fewer than 50 minutes played

If the match is abandoned solely because of the weather conditions (including bad light) or serious injury to the player when fewer than 50 minutes have been played, the match will be replayed unless the Competition Organiser exceptionally, and in its absolute discretion, agrees/specifies otherwise.

6.1.3. Abandoned with 50 or more minutes played

If a match is abandoned solely because of weather conditions (including bad light) or serious injury to the player when fifty or more minutes have been played, the score at the moment of abandonment shall stand and be deemed the final score in the match. The Referee's decision as to the necessity for abandonment and the number of minutes played at the moment of abandonment shall be final.

6.2. Other Reasons

If the Referee finds it necessary to abandon a match for any reason other than weather conditions (including bad light), irrespective of the number of minutes played, the result of that match shall be reviewed by the Competition Organiser. The Competition Organiser may order the match to be replayed and/or impose such other sanction as it deems appropriate. The Referee's report must be submitted on why play was curtailed.

7. Match Officials

- 7.1. The responsibility for providing Match Officials for each match will be in accordance with the Competition Regulations Schedule.

8. Disciplinary Procedures

- 8.1. The RFU has the power to investigate all allegations of foul play or misconduct on or off the field of play, and all such matters shall be dealt with in accordance with the Age Grade Rugby Disciplinary Procedures, as detailed in Appendix 6 of RFU Regulation 19.
- 8.2. When any player is sent off or cited in any match in the Competition, the Disciplinary Regulations and Procedures for Age Grade rugby will apply as set out in Appendix 6 of RFU Regulation 19.
- 8.3. Any rugby disciplinary incident that arises in a School, College or Club match shall be reported to the CBAGDS within 48 hours by the school, college, club disciplinary officer or person(s) with delegated authority.
- 8.4. A player who has been suspended from Club Rugby or Schools' Rugby may not play in any other competition matches whilst under suspension.

- 8.5. Playing sanctions imposed on an Age Grade Player are to be in accordance with the framework set out in RFU Regulation 19 Age Grade Rugby sanctions table. Any non-playing sanctions imposed are only to be in addition to the playing sanction.

9. Disputes and Breaches of Regulations

- 9.1. Subject to the right of appeal in accordance with RFU Regulation 19, the Disputes Committee shall have the power to discipline any Entrant or person for breach of any of these Regulations and/or any RFU Regulations. Ignorance of any such regulations cannot be deemed an excuse in the event of breach.
- 9.2. Any matters alleged to be in breach of these Regulations and/or RFU Regulations shall be referred immediately to the Disputes Committee; c/o the Competition Organiser within 24 hours following the conclusion of a match. Written confirmation must be sent to the Competition Organiser within 48 hours of the conclusion of the match setting out the grounds of the complaint/breach in full.
- 9.3. The Disputes Committee shall have jurisdiction to impose such penalty as it thinks fit including, but not limited to, financial sanctions, disqualification and suspension. For the avoidance of doubt, this power shall include a power to impose any sanction for breaching these or any other RFU Regulation, in line with tariffs and guidelines where these exist.

10. Sanctions

- 10.1. Having reviewed the Competition Organiser's evidence or the Disputes Committee finds a breach of a Regulation has occurred, it may bring breach proceedings. If it feels there is a case to answer the party committing the alleged breach will be notified and given an opportunity to make submissions or attend a hearing. Such a hearing will be conducted as set out in Appendix 6 of RFU Regulation 19. The National Age Grade Disciplinary Secretary will be copied in to any such notification.
- 10.2. Sanctions open to the Disputes Committee in respect of any breach of these Regulations and/or RFU Regulations will include but are not limited to the following:
- Reprimand an individual or Entrant
 - A deduction of points
 - A fine up to £100 and/or an award or reasonable costs as scheduled by either the Disputes Committee and/or a complainant
 - Order a replay
 - Order that the result is that an Entrant has lost the match
 - Exclusion/disqualification of an Entrant from the Competition, for a specific period of time as the Disputes Committee may decide.
- 10.3. Any fines collected will be put towards the costs of this Competition. Failure by an Entrant to pay a fine or costs will be considered a further breach of these Regulations and may result in the removal of the Entrant from future competitions.

11. Right of Appeal

- 11.1. Should an Entrant or other party who is involved in the proceedings wish to appeal a decision of the Disputes Committee, that party shall have a right to appeal in accordance with this Regulation 11.

- 11.2. Such aggrieved party may, within 72 hours from the receipt of the letter or notice informing it of the Disputes Committee's decision, lodge an appeal in writing to the Competition Organiser, who shall then notify the National Age Grade Discipline Secretary and the RFU Head of Discipline.
- 11.3. The National Age Grade Discipline Secretary, together with the RFU Discipline Department, will direct how the appeal will be heard and conducted and will issue case management directions until a panel is appointed to hear the appeal. Any appeal will normally be determined by written submissions unless the National Age Grade Discipline Secretary and RFU Discipline Department consider it appropriate to have a live hearing in which case such hearing will take place as soon as practicable to avoid undue delay to the next round. The decision of the appeal panel is final.

12. Broadcasting, Media and Image Rights

- 12.1. All broadcasting, media and image rights relating to the Competitions belong solely and exclusively to the RFU, and all participating entrants agree not, by any act or omission, to do anything to prejudice, or that is in conflict with, these rights.
- 12.2. In all Competition matches participating teams may record matches for the purpose of analysis and non-commercial purposes only unless a reasonable objection is received from a participating team.
- 12.3. Anyone wishing to broadcast any match by means of radio, television or any other audio-visual or electronic media must obtain permission from the RFU by contacting the Competition Organiser.
- 12.4. No team shall take any part (either as organiser or participant or in any other way) in any match that is in whole or in part broadcast by means of radio, television or any other audio-visual or electronic media, where doing so shall be a breach of any broadcasting, or other, contract entered into by the RFU or any other person acting for or on behalf of itself or any group or association of Clubs, Schools, Constituent Bodies or Unions.

13. Obligations

- 13.1. Each Entrant entering its team in this competition agrees:
 - a) that, by commencing its programme of matches in the Competition, it has entered into a legally binding obligation with the RFU, and, as a separate covenant, with every other team in the Competition and with any sponsor and/or commercial partner as may be associated with the competition in which the team plays;
 - b) to comply in every particular with these Regulations, the RFU Rules and Regulations, and the World Rugby Rules/Regulations;
 - c) to permit access to its premises during a match to any person authorised by the RFU, or Competition Organiser (with or without notice) to check compliance with all or any of the above Regulations.
