### QUILTER KIDS FIRST CHAMPIONS NOMINATIONS TERMS AND CONDITIONS

#### Full Terms and Conditions

1. The Promoter is Old Mutual Wealth Business Services Limited of Old Mutual House, Portland Terrace, Southampton, SO14 7EJ, and these are the Terms and Conditions on which the Promoter is offering the promotion to you.
2. The Promoters marketing agency, who assist the Promoter with the administration of the promotion, is Essentially Sports Marketing (Essentially).
3. This promotion is only open to United Kingdom residents aged 18 or over.
4. The instructions provided at the point of entry form part of the terms and conditions of this promotion. In the event of a conflict, these Terms and Conditions take precedence.
5. **To Enter:** Entrant must complete the electronic form on the <https://quilterkfchampions.typeform.com/to/eo4dE2> website. Entrant must enter their name, email address, telephone number, school / club name, Champion nomination and reason for the Champion nomination during the Promotional Period.
6. **Promotional Period:** Entries must be submitted between 00:00 on 04 June 2018 and before 00:00 on 01 April 2019. Entries submitted outside of the Promotional Period are automatically disqualified.
7. In entering the promotion, you confirm that you are eligible to do so and eligible to claim the Prize. Essentially may require you to provide proof that you are eligible to enter the promotion.
8. Only one entry per person will be permitted into the overall prize nomination pool throughout the Promotional Period.
9. No entries from agents, third parties, organised groups or entries automatically generated by computer will be accepted. No incomplete or corrupted entries will be accepted. Entries will only be accepted if they comply with all entry instructions.
10. If any group of people elects to collaborate on an entry, they are required to designate one person as the agent of the group to enter the promotion, agree to these Terms and Conditions and accept the Prize on behalf of the group.
11. **The Prize(s)** – A total of 8 schools / clubs will be chosen as winners and identified as Quilter Kids Champions. Each winning school / club Champion Prize includes the opportunity to:
  - i. host a filming day at their school/ club with a rugby legend; and
  - ii. attend the Quilter First Pitch Day 2019.
12. **Further Prize Details and Conditions**  
Filming day with a rugby legend
  - Filming will occur once monthly from [September 2018] – [April 2019].
  - Each winning school / club will be invited to host one filming day, at a date to be confirmed, between [September 2018] and [April 2019].
  - The Promoter will produce a content film profiling the school/ club and their rugby provision of Quilter Kids First.
  - This film will be distributed on the Promoter's and England Rugby social media channels.

- To participate in the filming day, winners and all attending individuals will be required to sign a filming waiver form that will be shared prior to the event
- Winners are responsible for the behaviour of themselves and attending individuals whilst taking the Prize. Both the Promoter and the RFU each reserve the right in their absolute discretion to exclude winners and/or individuals from participation in or attendance to the Prize if:
  - any party fails to comply with the directions of the Promoter, the RFU or any companies associated with the Prize; or
  - In the opinion of the Promoter or the RFU, the winners and/or individuals act in a manner that is dangerous to themselves or to the public; or
  - in the opinion of the Promoter or the RFU, the winners and/or individuals act in an anti-social manner or a manner which causes a disturbance or nuisance to others.

Quilter Kids First Training Day 2019

- Each of the 8 winning schools/clubs will be invited to take part in the Quilter Kids First Pitch Day at Twickenham Stadium at the end of the rugby season (date to be confirmed).

- Winners must be available to take part in the Prize on the date confirmed by the Promoter – no alternative dates are available.

13. **Winner Selection and Notification:**

- All entries which have (1) been submitted in accordance with these Terms and Conditions, (2) not been disqualified, and (3) been received within the Promotional Period will be entered into a prize nomination pool for a chance to win the 'Prize'.
- Entries will be reviewed by a selection panel board against the following criteria:
  - creating a great rugby environment,
  - upskilling coaches,
  - retaining/ growing participation.
  - Commitment to girls rugby
- The eight (8) winning schools / clubs will be selected by the panel during the following Champion panel selection meetings:
  - w/c 04 June 2018 (September Champions selected);
  - w/c 02 July 2018 (October & November Champions selected);
  - w/c 24 September 2018 (December Champions selected);
  - w/c 22 October 2018 (January & February Champions selected);
  - w/c 17 December 2018 (March & April Champions selected)
- If a selected winner does not pass the RFU Safeguarding checks their entry will be deemed illegible and a new winner will be drawn from the entry pool.
- Selected winners which do pass the RFU Safeguarding checks will be notified by Essentially (or their agents) by email or telephone using the contact details provided by the winner within 3 days of the Champion panel selection meeting. The winners will be required to respond to Essentially within 72 hours confirming their acceptance of the Prize. In the event that any or all of the winners do not respond to communications within this period or if the Prize is declined, the Promoter reserves the right to disqualify that winner and nominate and award the Prize to a reserve winner.

14. **Moderation:** Each of the Promoter, the RFU and Essentially will reject entries which, in the reasonable opinion of the Promoter, the RFU, and/or Essentially:
  - contain any content that is offensive or could reflect negatively on the name, reputation, or goodwill of the Promoter or any brand partner;
  - include trademarks, logos, images or copyright material not owned by you or used without the rights owner's prior written permission (including famous names, company names, etc.);
  - defame, misrepresent, or insult other people or companies, including, but not limited to the Promoter (including its partners); and
  - promote any political agenda.
15. If a previously confirmed winner for a Prize contacts the Promoter, the RFU, and/or Essentially outside of the winner communication timeframe (as stipulated in clause 6), to then decline their Prize the Promoter reserves the right to cancel that Prize.
16. Each of the Promoter, the RFU and Essentially may, in their sole discretion, disqualify entries deemed to be non-compliant with these Terms and Conditions and the both the Promoter and the RFU reserve the right to refuse entry to or disqualify any entrant whose conduct may be unlawful or otherwise bring the Promotion into disrepute. In the event of such disqualification the Promoter may award the applicable Prize to another entrant.
17. The decision of the Promoter regarding any aspect of the promotion is final and binding and no correspondence will be entered into.
18. The Promoter accepts no responsibility for late, incomplete, incorrectly submitted, corrupted or misdirected entries. Any incorrect information provided will render the entry void.

In the event for any reason a prize winner does not take an element of the Prize at the time stipulated by the Promoter, then that element of the Prize will be forfeited by that winner and neither cash nor any other form of compensation will be supplied in lieu of that element of the Prize. However, the Promoter reserves the right to provide an alternative prize of equal or greater value in the event of unforeseen circumstances.

If for any reason any aspect of this promotion is not capable of running as planned, including by reason of infection by computer virus, network failure, bugs, tampering, unauthorised intervention, fraud, technical failures or any cause beyond the control of the Promoter, the RFU or Essentially which corrupts or affects the administration, security, fairness, integrity or proper conduct of this promotion, the Promoter may in its sole discretion cancel, terminate, modify or suspend the promotion, or invalidate any affected entries.

If for any reason the event is not capable of running as planned, such as cancellation or any other cause beyond the control of the Promoter, the RFU or Essentially which affects the running or conduct of this promotion, the Promoter may in its sole discretion cancel the Prizes and not be required to reimburse any incurred expenses by a winner as a result of winning or accepting the Prize.
