



**AGENT ACTIVITY DECLARATION – PREMIERSHIP**  
*Effective from 14 January 2019*

**The purpose of this Agent Activity Declaration (‘Declaration’) is to ensure full transparency is provided to all parties in respect of fees, payment and representation relating to the recruitment or retention of a Player at a Club. It is understood that some fees might be a 100% P11D liability for the Player, while in other cases the liability may be split between the Player and the Club. This declaration provides for both approaches.**

This Declaration must be completed by all parties correctly and accurately when a Player enters into an agreement with a Club (or if centrally contracted, with a Home Union) and regardless of whether or not an Agent has been acting for either the Player or the Club/Union. This is a requirement of RFU Regulation 8.4.4.

The Declaration must be signed and returned by the Club to Premier Rugby Limited who will confirm receipt to the RFU to enable the player’s registration.

- The Agent and Club has explained the implications of the arrangements to the Player;
- The Player has been given the opportunity to take independent advice;
- The information contained in the present form is correct, complete and accurate to the best of their knowledge;
- Pursuant to the requirements of the Regulations, the undersigned are required to provide the above information to Premier Rugby Limited and/or the Rugby Football Union;
- That the undersigned have completed and supplied to Premier Rugby Limited the relevant representation contract(s) and disclosure documents in relation to the transaction and that no payment to an Agent, other than that specified in the relevant representation contract(s) or on the present form, will be made, sought or accepted by the undersigned in respect of this transaction;
- Each Agent confirms he/she is permitted to act on behalf of the relevant parties. The provision of untrue or misleading information may result in disciplinary action.
